### Course Description:

This course covers several advanced topics in microeconomic theory. We begin with the theory of general equilibrium, where the main goal is to remind students what they learned from the intermediate microeconomics course and help students to well understand the concept of equilibrium. Then, we study how individuals interact with each other in a game theoretical setting. Four types of games (static/dynamic games with complete/incomplete information) are carefully studied, which serve as analytical frameworks for the topics of principal-agent problems, bargaining problems, and auctions. Finally, we give an elementary introduction to two important and interesting topics in theory: matching and social networks, which become very popular in recent years.

In order to do well in this course, the students should be familiar with calculus, elementary optimization techniques and basic probability theory.

### Textbook & Reference:

There is no required textbook for this course. The lecture is mainly based on the following books and related journal articles. The book by Gibbons is strong recommended to students who pursue further study in microeconomic theory.

## **Problem Sets**

Homework assignments will be posted to the online blackboard platform (CUSIS). You have at least one week to work on each problem set. Some of the homework questions are intended to be instructional; you may find them challenging. The due date of each assignment will be specified. Please hand in your answer sheet in class or submit it by 10:00pm of the due date to the instructor's assignment drop box on the 9<sup>th</sup> floor of ELB. Late submissions are not accepted without valid excuses, which refers to a verified illness with a medical note or endorsement by the University Health Center.

Students are encouraged to work together on assignments, but must write their own answers independently.

Grading of the homework will be done at the week following the due date, and comments and explanations on homework questions will be provided by TA in the associated tutorial sessions. Students should expect to receive their graded assignments in a week after the submission.

## **Exam and Policy**

The final exam is scheduled in class on December 3<sup>rd</sup>, counting for 60% of the total grades and covering all the topics taught in weeks 1-10.

There is in general no option for having a make-up exam. If a student misses the exam for no valid excuse (referring to a verified illness), he or she will receive zero grade for the exam. If a student does have a valid excuse to miss the exam, a new exam covering the same course material will be arranged for this student. However, there is no guarantee that the difficulty level of the make-up exam is the same as the regular exam.

Please note that conflicting travel plan is not a valid excuse for requesting a make-up exam.

## **Re-grading Policy**

If a student would like to appeal to re-grade his/her answer sheet of the homework/exam, a formal request must be made within one week of the notice of the grades for the answer sheet in question. Instead of only re-grading the parts specified by the student, the whole answer sheet will be re-graded, which implies that the updated grades may become lower than before.
